**TULALIP, Wash. (March 8, 2023)** – With the NFL’s “Big Game” in the books, sports fans are now looking forward to a line-up of other major sports events, including televised “March Madness” action kicking off Tuesday, March 14 at the DraftKings Sportsbooks at Tulalip Resort Casino and Quil Ceda Creek Casino. Both will offer special activities and live, in-game sports betting and prime viewing opportunities on the largest LED screens in the Northwest.

**Tulalip Resort Casino** is offering reserved seating in its 5,005-square-foot DraftKings Sportsbook where guests can reserve booths, tables and chairs for all-day viewing and wagering. Seating for the “Big Game” was sold out and reservations for games during “March Madness” are recommended. Pricing for guaranteed seating for special events is \$400 for booths seating 8, \$150 for tables seating 6, and \$50 per chair. Reserved seating is also available for other major events and UFC bouts with special booth pricing on “non-event” days.

Offering cocktail service and a variety of menu options, the DraftKings Sportsbook at Tulalip Resort Casino is the ultimate sportsbook experience where fans can view up to 10 live sporting events on an impressive LED television screen spanning more than 800-square-feet. Guests can

place bets at 20 kiosks and four over-the-counter ticket windows. Another 10 sports betting kiosks are conveniently located throughout the casino's gaming floor.

Throughout "March Madness" **Quil Ceda Creek Casino's** DraftKings Sportsbook at "The Stage" features viewing on four video walls spanning 896-square-feet while displaying up to 10 different views simultaneously. "The Q" features 20 sports betting kiosks and three over-the-counter ticket windows.

"March Madness" concludes with the "Final Four" games (Saturday, April 1, starting at 3 p.m.) followed by the Championship Game (Monday, April 3, game time TBA), and Quil Ceda Creek Casino is teaming up with Maui Brewing Company for a special promotion both days with a decidedly "island" flavor.
